PHILOSOPHY & APPROACH

- Westfield's Select Growth Equity strategy employs a growth investment style within a responsible risk framework, which we believe results in more consistent results both relative to the benchmark and our large cap growth peers. We favor investing in earnings growth stocks based on our belief that:
 - Stock prices ultimately follow earnings growth, and;
 - Fundamental research best identifies inefficiencies and investment opportunities.
- The strategy concentrates Westfield's active management skill into a portfolio of typically 35 stocks or fewer to provide an enhanced return/risk profile.
- William A. Muggia, President, Chief Executive Officer and Chief Investment Officer, is the sole manager of the strategy and has been since its inception.




SECTOR EXPOSURE

Net performance was calculated using actual management fees, which includes performance fees. The performance-based fees typically consist of a base fee component and a total maximum fee of 1.30%. Information regarding period specific fee schedules is available upon request. The three-year annualized standard deviation measures the variability of the composite gross returns, and the benchmark returns over the preceding 36-month period. The three-year annualized standard deviation is not presented for 2014 and 2015 because the composite did not yet have 36 monthly returns. The annual composite dispersion presented is an asset-weighted standard deviation calculated for the accounts in the composite the entire year using gross returns. For those periods with fewer than five accounts included for the entire year, "N/M" is noted as the dispersion is not considered meaningful.
